The Supreme Court's landmark decision regarding judicial review is Marbury v. Madison, 5 U.S. (1 Cranch) (). Marbury was the first Supreme Court decision to strike down an act of Congress as unconstitutional. So, under the Judiciary Act, the Supreme Court would have had jurisdiction to hear Marbury's case. The best-known power of the Supreme Court is judicial review, or the ability of the Court to declare a Legislative or Executive act in violation of the Constitution, is not found within the text of the Constitution itself. The Court established this doctrine in the case of Marbury v. Madison ().
